ORDER No. 07/2017- Accident

Whereas Piper Seneca PA-34 aircraft VT-BCA, of M/s Bombay Flying Club, while operating flight from Surat to Gondur Airport, Dhule met with an accident at Datarti Village, Maharashtra on 1st of December 2017.

And, whereas it appears to the Aircraft Accident Investigation Bureau (AAIB), India that it is expedient to investigate and determine the probable cause(s) and contributory factor(s) leading to the accident and make recommendations to avoid reoccurrence of such accidents in future.

Now, in exercise of the powers conferred by the Rule 11 (1) of the Aircraft (Accident and Incidents Investigation) Rules 2017, the Director General-AAIB, India hereby directs an Investigation of the said accident for the probable cause(s).

The Director General-AAIB, India is pleased to appoint Sh. Raje Bhatnagar, Assistant Director, AAIB as Investigator – in – Charge. He will be assisted by the following investigator(s) to inquire into the circumstances of this accident.

1. Sh. Dinesh Kumar, Air Safety Officer, AAIB.

The Investigator-in-Charge will also take the assistance of other experts/agencies whenever required.

The headquarters of the Investigation will be at New Delhi.

The Investigator-in-Charge will complete its inquiry and submit the report to AAIB, India, preferably within six months from the date of issue of this order.
