ORDER- Serious Incident

Whereas Boeing B77W aircraft HZAK14 flight SVA862 of M/s Saudi Arabian Airlines operating flight from RIYADH to Manila and Boeing B744 flight UPS15 of United parcel Service (UPS) met with a serious incident in Kolkata airspace on 16.10. 2018.

And whereas it appears to the Aircraft Accident Investigation Bureau (India) that it is expedient to investigate and determine the causes and contributory factors leading to the serious incident and make recommendations to avoid reoccurrence of such serious incidents in future.

Now, in exercise of the powers conferred by the Rule 11 (1) of the Aircraft (Accident and Incidents Investigation) Rules 2017, the Director General-AAIB hereby directs that a formal inquiry of the said accident be held.

The Director General-AAIB, India is pleased to appoint Dr. Jitender Loura, Deputy Director, AAIB as Investigator – in – Charge with following investigator(s) to inquire into the circumstances of this serious incident.

1. Sh. K Ramachandran, Assistant Director – AAIB

The Investigator – in -Charge will also take the assistance of other experts/agencies whenever required.

The headquarters of the Investigation will be at New Delhi.

The Investigator-in-Charge will complete its inquiry and submit its report to the AAIB, India preferably within ten months from the date of issue of this order.
